1. Healthy Campus 2020 Writing Meeting

2. Coalition Survey Results. Thanks to Bob Ward for preparing an informative graphic summary of the Coalition survey results. The range of participation among ACHA members and among other organizations represented in the Coalition was impressive. At the Writing Meeting, the group will discuss which focus areas remain of greatest interest and importance, and what criteria will be used to determine which focus areas should be included for the Healthy Campus 2020 document. Everyone is asked to pay attention to the focus areas for which they signed up.
3. Healthy People 2020 Update. Thanks to Jim for all of his efforts to inform us about different Healthy People 2020 related conferences, conference calls, and other information. Jim and Michelle plan to attend a DHHS meeting on Healthy People 2020 in Washington, D.C. on September 17 and 18.
4. Discussion:
 - a. How to handle feedback during writing process—A number of channels for communicating comments about the proposed objectives for Healthy Campus 2020 were suggested including webinars, conference calls, regional annual meetings, open forums, email, and web-based conferencing. A transparent and participatory process among Coalition and ACHA members is important.

- b. Timeline of project---The DHHS plans to release the Healthy People 2020 in November 2010. The Coalition is proposing to complete the Healthy Campus 2020 by January 2011. Bob Ward noted that in order for the document to be available January 2011, we must have the final version to ACAH for printing by November 2010. Bob noted that the ACHA annual meeting theme for 2011 that is being considered will relate to the HP2020 and HC2020. That would be a positive move to support distribution of Healthy Campus 2020.
- 5. American College Health Association Annual Meeting
 - a. Coalition's Presentation to ACHA annual meeting has a "hold" on slot. At the Writing Session, an outline or formal proposal about HC2020 will be written and submitted to the program planning committee.
- 6. There will be no Coalition conference call in September. The next conference call will be on Tuesday, October 27 at 3 PM EST.
