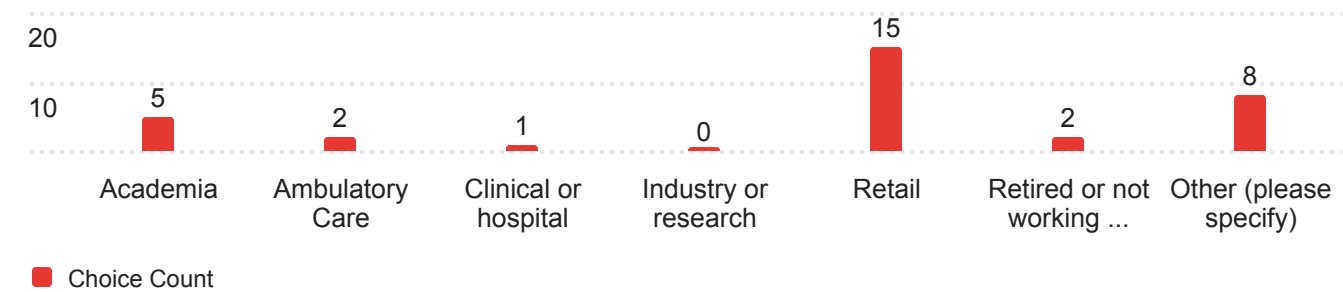

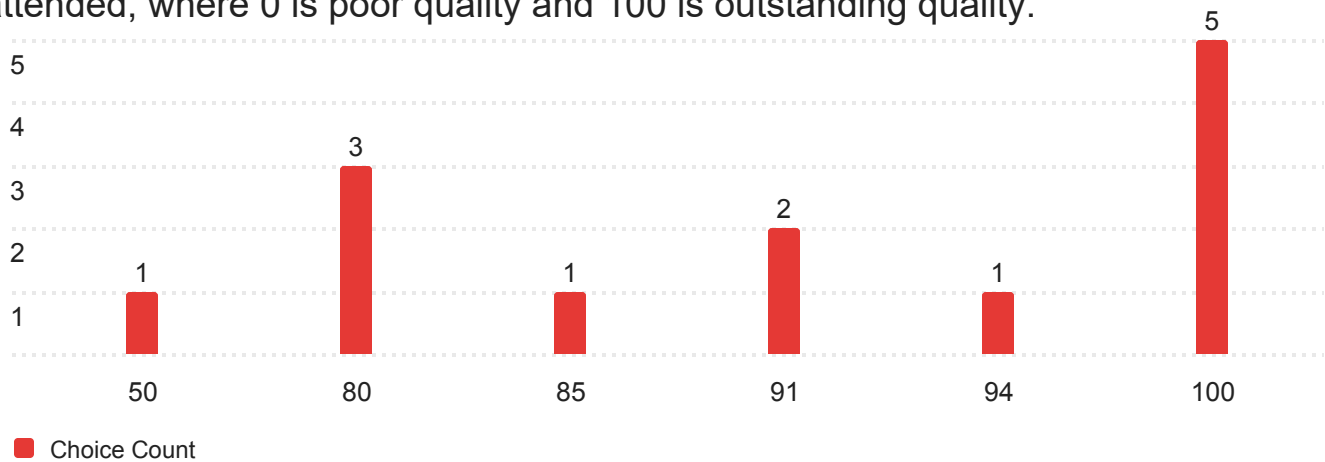

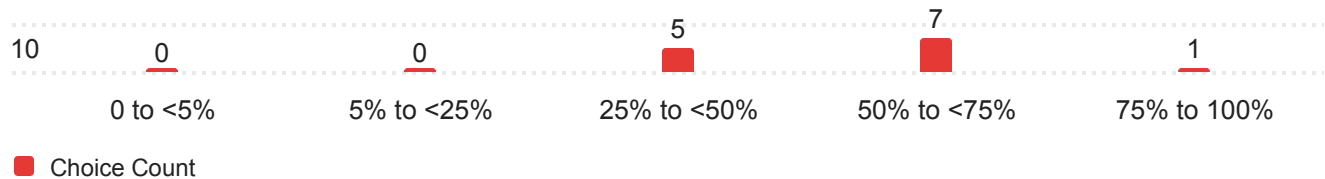

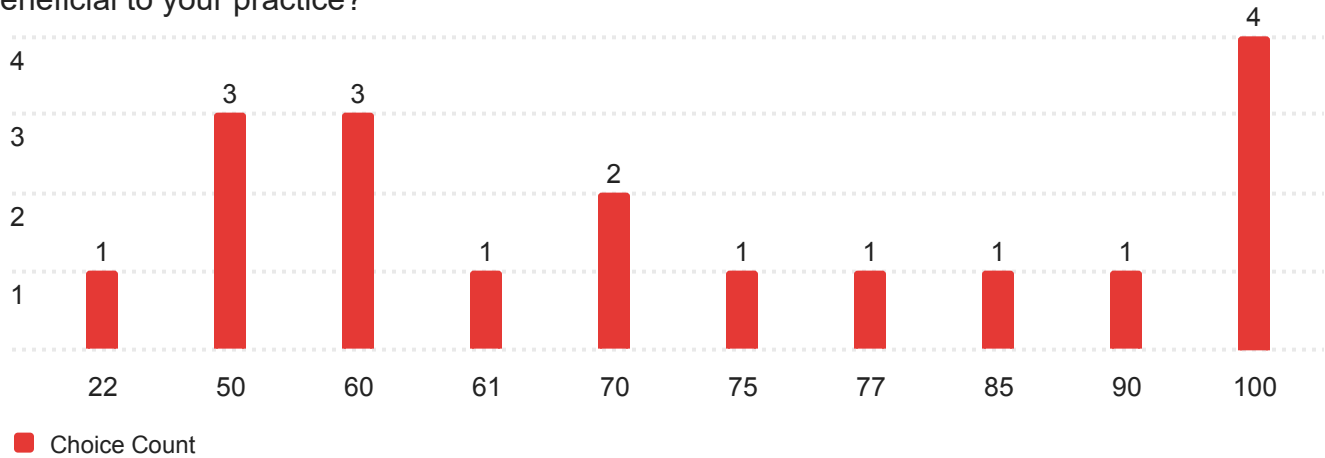

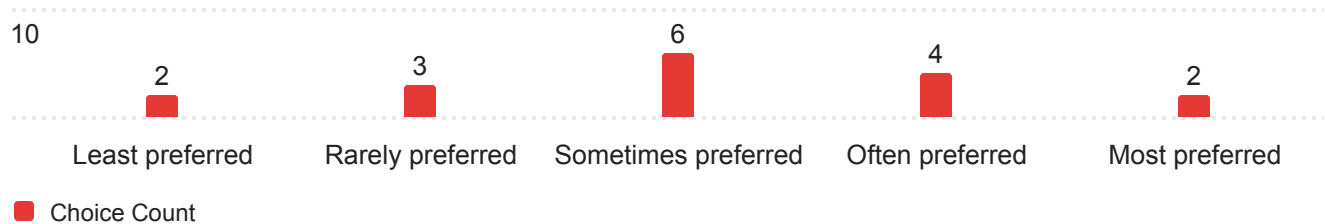

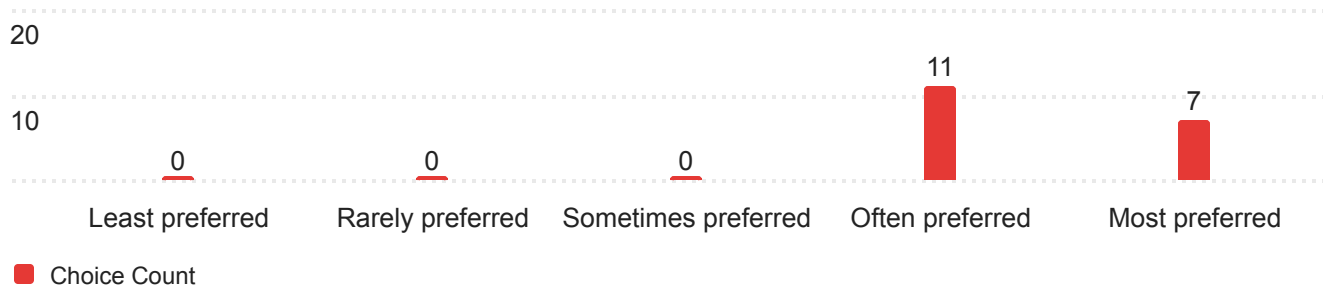

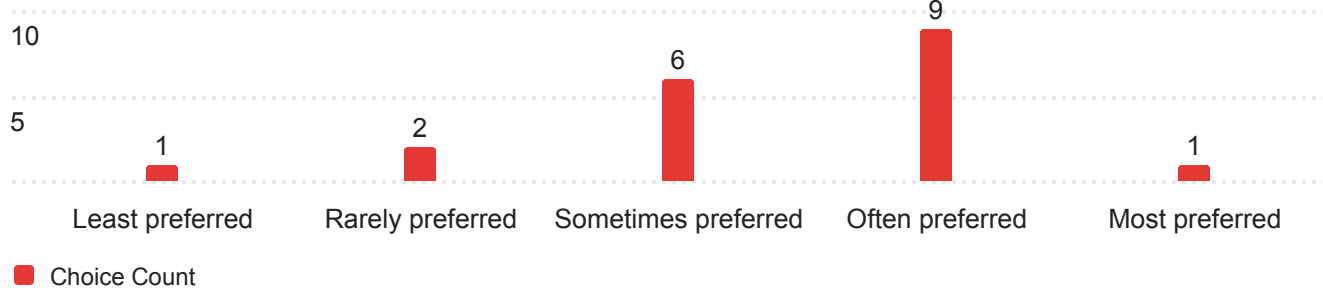

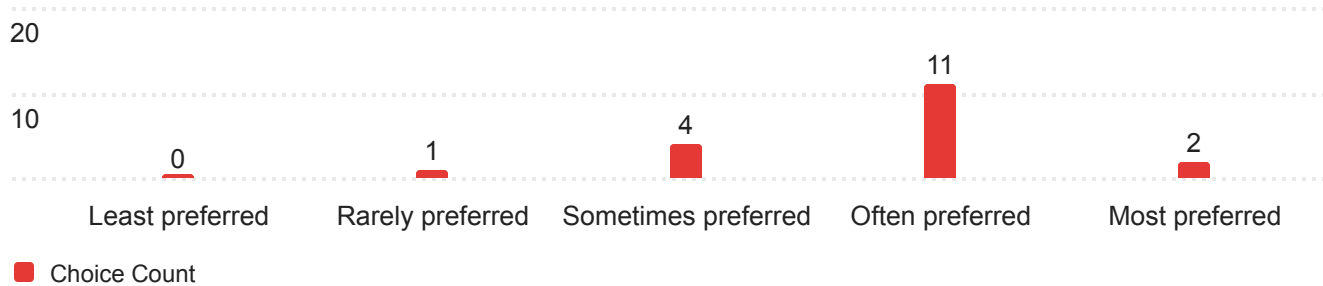
Q13_3 - Open case discussions



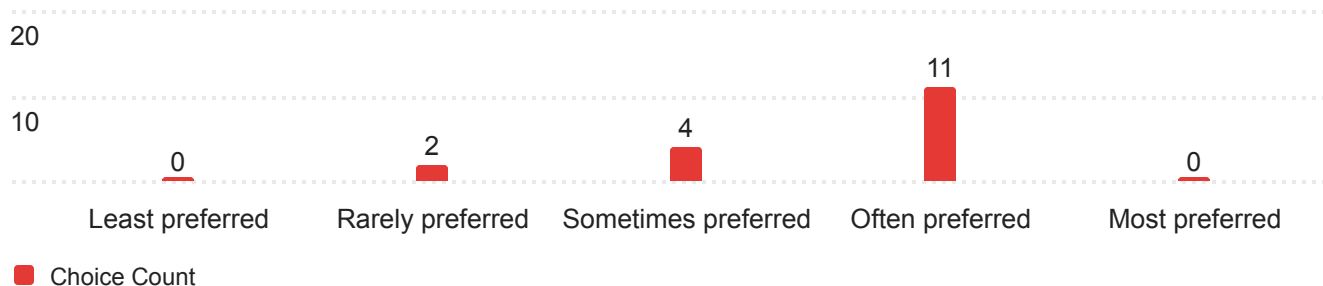

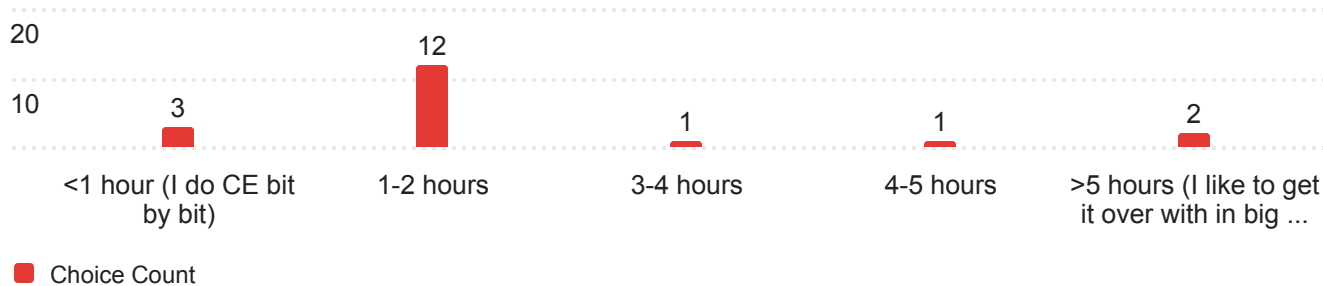
Q13_5 - Panel discussion



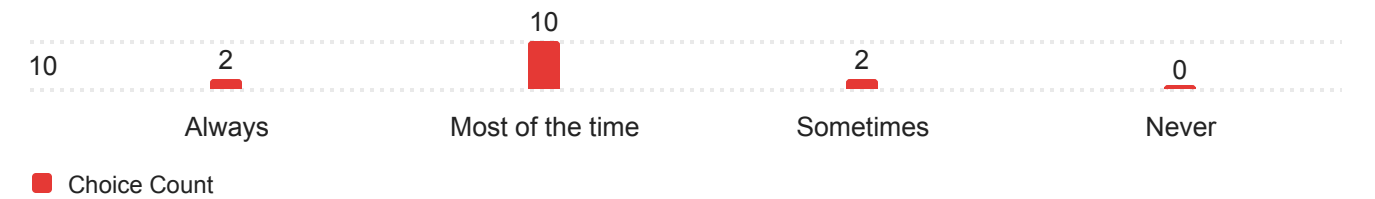
